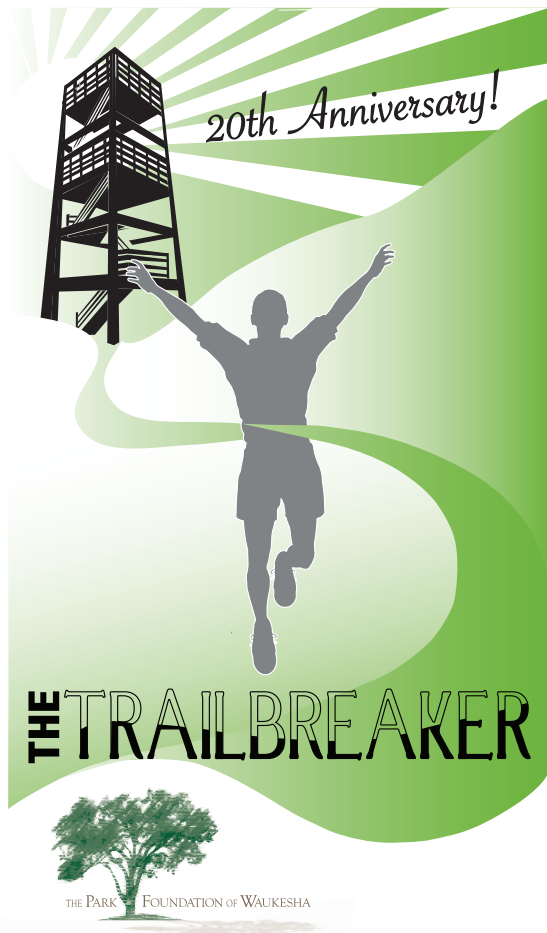

**Waiver of Claims, Release of Liability and Agreement to Indemnify
Signature Required for Participation – Read Completely and Sign Below**

I have submitted this registration form to participate in the Trailbreaker Marathon, Half Marathon or 5K Run/Walk on March 31, 2012, and all related activities before and afterward (the "Trailbreaker"). I make the following waiver, release and indemnification to the Park Foundation of Waukesha, Inc, the City of Waukesha, and all sponsors and volunteers participating in the operation of the Trailbreaker (the "Organizers").

I understand that participation in the Trailbreaker carries the risk of physical injury or death. I understand that the route of the Trailbreaker passes over property that is not owned by or under the control of the Organizers, public roads, and railroad tracks; that conditions on the route are not controllable by the Organizers and may be unpredictable. I take full responsibility for my physical ability to participate in the Trailbreaker, and I represent that I am physically capable of participating safely in the Trailbreaker. I take full responsibility for following the course. **I assume all risks of participating in the Trailbreaker.**

In consideration of the Organizers accepting my registration and allowing me to participate in the Trailbreaker, I (whether for myself or by my parent or legal guardian), and all those who may make a legal claim on my behalf or through me, **release the Organizers from all liabilities and legal causes of action that may arise from, or as a result of, my participation in the Trailbreaker; release and forever discharge all such liabilities and causes of action; and agree to indemnify and hold the Organizers harmless from all such liabilities and causes of action.** I understand that "liabilities and causes of action" includes negligence, but that I am not releasing liability for intentional harm done to me. I understand that this means that I may not sue the Organizers for any physical injuries or loss or damage to property that occur while I am participating in the Trailbreaker, except harm that is intentionally done to me.
